
#### 1.0 General information:

#### 2.0 Intended use / product description

For the use during gastrocopic and bronchoscopic treatments. The Bite-Block is used to protect the endoscope insertion tube from being bitten by the patient.

The Bite-Blocks are constructed as follows:

## 4.0 Composition / Product specification

- 1. The Bite-Blocks are smooth, clean, without unevenness and burrs.
- 2. The head-straps are soft, elastic and latex free.
- 3. Wide openings at the side / atraumatic geometry

## 7.0 Advices before first application

- 1. Examine the packaging for any possibility of damage and Bite-Block for usability.
- 2. Examine the Bite-Block for damages, contaminations etc. Do not use the Bite-Block in case of irregularities.

## 8.0 Handling and Operation

- 1. Unpack the Bite-Block and remove it from the pouch.
- 2. Place the Bite-Block carefully in the patient's mouth and avoid placing your fingers between the bite-Block and the patient's teeth. Pass the strap around the patient's neck and attach it again to the bite block while belaying the patient's head.
- 3. Remove the Bite-Block carefully from the patient's mouth after the examination and discard the device as medical waste according tot he national regulations.

## 9.0 Hazard note /!

- 1. This devices is for single use only. Discard the Bite-Blocks after the first use. The reuse of single-use devices might present risks to the safety of the user or patient, due to possible uncontrolled contamination and / or unreliability of the device performance.
- 2. Should sharp edges be examined, discard the Bite-Block to prevent the patient from beeing hurt.

## 10.0 Packaging and storage

Single packaging in PE pouch. 50 pouches in protective carton. Store cool and dry (humidity below 80%). Do not expose the device to direct or indirect sunlight or other ultra-violet rays!
